

Terms of Payment

The Cemetery expects all payments to be made by cash, bank draft, cheque or e-transfer within 15 days following receipt of our invoice. **Fees for interment services should be paid at or before the interment.**

Surcharges will usually be invoiced with the initial invoice when they can be predicted. Late charges and other variable charges will be invoiced to the deceased's estate or estate trustee after the date of interment.

Cheques are to be made payable to: "Perth Cemetery Company". Payment can also be made via e-transfer to accounts@elmwoodcemeteryperth.ca

Service charge of 18% per annum on overdue accounts after 15 days.

All prices charged will be from the Cemetery's latest price list. All earlier price lists are deemed void.

Please note that Cemetery charges are in addition to charges from Funeral Directors and are invoiced separately and directly by the Cemetery.

The Perth Cemetery Company has been operating Elmwood Cemetery continuously since March 27, 1872.

The Company is a registered **not-for-profit** organization that owns the cemetery property and therefore has full control and complete authority to administer the by-laws and regulations. The management and direction of the cemetery is entrusted to an elected Board of Trustees. All members of the Board must be Interment Rights Holders of Elmwood Cemetery.

The Board of Trustees has oversight of the Cemetery Manager, who in turn has responsibility for the day-to-day management of the Cemetery.

The Perth Cemetery Company Board of Trustees, in the discharge of their responsibilities, appeal to the public to aid them by following the by-laws of Elmwood Cemetery, which have been adopted for the improvement and upkeep of the Cemetery, to keep it a respectful place for the burial of the dead.

Elmwood Cemetery is licensed to act as a cemetery in accordance with the Funeral, Burial and Cremation Services Act, 2012.

It is our hope that, by a co-operative effort, we can keep the Cemetery attractive and peaceful.

Columbarium Interment Rights

Niches

All niches may contain 2 urns.

Units A to E are located near the Cemetery gate and units F to H are at the rear of the Cemetery.

Niches in units A to G have plain granite doors which may be engraved at the rights holder's expense:

Units A to E	\$1400
Units F and G	
Rows 1-2	\$2050
Rows 3-4	\$1850

Niches in unit H include a bronze plaque for each door which may contain names and either full dates or years only for birth and death:

Unit H	
Rows 1-2	\$3100
Rows 3-4	\$2900
Rows 5-6	\$2700

Note: The Cemetery is required to deposit 15% of the Interment Rights price for niches and private columbariums into the Care and Maintenance Trust Fund.

Note: The Cemetery is required to deposit 40% of the Interment Rights price into the Care and Maintenance Trust Fund.

Interment (opening/closing) Fees

When budgeting for your cemetery arrangements, it is important to consider all potential charges. The fees are payable at the time of interment:
